## **Spiritual Qualifications**

Must be 18 years of age and older.

- 1. Must be a born again (baptized) believer.
- 2. Must be an ordained SBC pastor.
- 3. Must be a man with one wife; he and his wife have never been divorced before.
- 4. Must have strong commitment to HBNA's purpose and be a good Christian role model.
- 5. Must be a long standing and a current, active member in an HBNA church that financially supports HBNA.
- 6. Commitment to teaching Biblically based Christian principles in a professional and personal setting distinctive to HBNA guidelines.

#### **Basic Function**

Manage Hmong Baptist National Association (HBNA) organization in planning missions and ministries that draw unreached people-groups to the body of Christ; develop educational programs and leadership literatures; and seek out other resources to support HBNA member churches and its Christian leaders.

#### **Education**

- 1. Bible Bachelor Degree (Required) or Master Degree (preferred but not required).
- 2. Other degrees and/or other certifications are helpful but not required.

#### Skills

- 1. Read and write both English and Hmong fluently.
- 2. 1-5 years Leadership training experience is required.
- 3. Minimum 5 years of senior pastoral experience.
- 4. 1-3 years non-profit organizational experience is required or equivalent.
- 5. Proficient working knowledge and ability to use Microsoft Word, Excel, PowerPoint, Publisher, Microsoft Access, Google Email and Internet skills is a must.
- 6. Strong leadership and Good communication skills are a must.
- 7. Knowledge and affirmation of SBC Doctrine (Baptist Faith & Message 2000).

#### Other Requirements

- 1. Willing to relocate to St. Paul, MN (non-negotiable).
- 2. Candidates must agree to sign a work contract with HBNA.
- 3. Ability to maintain confidentiality.
- 4. Ability to establish and maintain effective working relationships with staff, vendors, churches, committees, organization, etc.
- 5. Must have excellent organizational skills; and ability to multi-task.
- 6. Able to network with local, state, national, and international SBC organizations.
- 7. Professionalism in the workplace includes professional ethics and effective communication with others.
- 8. Background check required.
- 9. While employed, he must maintain a membership in a church supporting HBNA.

#### **Duties includes but not limited to**

- 1. Manage HBNA facility, Building and operate office operation.
- 2. Provide training to member churches as needed.
- 3. Create resources and develop essential leadership programs.
- 4. Manage TEE programs and develop other educational programs and materials.
- 5. Hold staff and board meetings on a quarterly basis.
- 6. Report to the HBNA President and boards quarterly.
- 7. Be able to travel to various locations of both national and international as required.
- 8. Attend SBC meetings and participate in training as required.
- 9. Develop and manage an annual HBNA budget.
- 10. Manage and supervise HBNA personnel, review staff and officers performance annually.
- 11. Maintain compliance with MN and WI State Convention policies and procedures.
- 12. Maintain compliance with all state and federal laws and regulatory requirements.
- 13. Perform ordination services as needed.
